

Redwood City Señors Softball Club

Tournament Team Sponsorship Application & Agreement

The Redwood City Señors Softball Club offers sponsorship benefits to its active Club members who have formed a team of players with the expressed interest of participating as a Tournament Senior Softball Team within the Northern California Senior Softball Association (NCSSA). If sponsorship is approved, they must comply fully with the specific requirements placed upon their sponsored team and understand that if these requirements are not met in total their sponsorship benefits will be suspended for the remainder of the current season.

Current sponsorship benefits for a season consist of the following:

- *Paid Team Registration and Insurance fees with NCSSA/SSUSA/ASA*
- No fees required for participation in the Redwood City Annual June Tournament
- A cash stipend to be made shortly after the Club's 4th of July One-Pitch Tournament

Sponsored Team Requirements consist of the following:

1. All Team members must continue to maintain current active membership in the Club.
2. Any new addition to the Team, who is not currently a Club member must become a member within 30 days of their being placed upon their Team Roster filed with NCSSA.
3. A promise to provide volunteer services to support Club functions; for example, the Annual Redwood City Señors June Tournament, the 4th of July One-Pitch Tournament and Family Bar-B-Que, Señors Games, and the Holiday Party.
4. A willingness to translate paragraph 3 above into a written document representing specific negotiated services and a handshake agreement.
5. Failure to comply with sponsorship requirements, as described, will bring about an immediate suspension of sponsorship benefits for the remainder of the current season.
6. Upon notification of suspension, the Team Manager/Coach, or his designated representative, may appeal that suspension either in writing or in person at the next regularly scheduled meeting of the Board of Directors.

Having read the above and understanding the conditional requirements for sponsorship as stated by the Redwood City Señors Softball Club, it is the desire of the Club Members listed on the reverse side of this agreement that they collectively apply for Club Sponsorship for *Tournament Season* _____.
